<p>Notice:</p> <p>By signing of this Order Form the passenger confirms that the stated data are correct and true. If the stated data are incorrect or false, especially as regards the vehicle size, the vehicle shall be excluded from transport.</p> <p>As regards refund requests, Železničná spoločnosť Slovensko, a. s. (ZSSK) handles them according to valid terms and conditions for domestic and international transport.</p> <p>ZSSK does not recommend to passengers to leave their valuable belongings, cash etc. in their vehicles. Belongings of passengers can stay during the journey inside the vehicles, subject to respective national terms and conditions as well as conditions of International Convention of International Carriage of Passengers by Rail (CIV), except of items that are prohibited to transport by respective customs and other official regulation.</p> <p>Transport of dangerous goods inside or on the vehicles must be in accordance with valid conditions for domestic transport and Regulation concerning the International Carriage of Dangerous Goods by Rail (RID).</p> <p>Passengers are obliged to fix their motorcycles, three-wheeleers, four-wheelers on the motorail coach by themselves by their own fixing devices (fixing belts).</p> <p>The carrier is responsible for damages on subjects inside the vehicles or on subjects in boxes that are securely attached to the vehicle only in the case, if the damage has been caused by the carrier.</p> <p>On a night train each passenger (the driver and the fellow-traveller) is entitled to one place in the sleeping coach assigned to the motorail coach (i.e. not entitled to a whole compartment) until the capacity has been sold out. On a day train each passenger (the driver and the fellow-traveller) is entitled to one seating place in the second class coach assigned to the motorail coach.</p> <p>If transport of a vehicle cannot be realized in due time (e.g. the car has been broken down etc.) and if the passenger decides to make his journey despite this fact, he/she is obliged to hand back all the travel documents related to the transport.</p> <p>The passenger notes that after loading of the car on the motorail coach the entry of persons is prohibited with regard to safety when moving under high voltage trolley wires.</p> <p style="text-align: right;">Signature of passenger:</p>
